5. Repair chlorine lines at pool and start feeding chlorine to pool.
6. Zoning violations.
7. Contact credit union in regards to zoning violation on vacant property.
8. Work on Hemple Rd Project.
9. Check Riley residence for flooding issues which was unfounded.
10. Repair council room door latch.
11. Demo concrete and piping for slide plumbing which had froze and busted the entirety of the plumbing for the slide.
12. Completed hydrant flushing for the entire Village.
13. Meeting with new law director.
14. Hang Flags and Banners for Memorial Day.
15. Address zoning complaints.
16. Contact Mr. Matt Fraley in regards to putting in time at both water and waste water plants as well as signing off on both plant reports.
17. Demo and replace bar screen and gate at wwtp.
18. Water and Waste Water duties.

19. Back wash water plant.

20. In the past 2 weeks, we have put in 40 plus hours at the pool to prep for opening day. With the help of the township and village employees, we had the pool opened and in service on time.


ADJOURN:
