

VILLAGE OF FARMERSVILLE
Minutes of Village Council Meeting
October 28, 2019

The Farmersville Village Council met in regular session on October 28, 2019 in the Village of Farmersville Council Chambers at 117 E. Walnut St. Mayor Daryl Weller called the meeting to order at 7:00 pm; Mayor Weller led the group in prayer; the Pledge of Allegiance was recited and followed by a roll call.

Chief Erisman informed the Council that there would be a Reunification Drill conducted at the Jr. High School on October 29, 2019. This is just a trial run to see how things work. Chief Erisman also reported that there are an 8,000 and 10,000 gallon underground oil tanks in the front parking lot and a 500 gallon tank buried out by the old warehouse in the back.

Mayor Weller read the second reading of the Jonathan Moore alley vacation.

OLD BUSINESS:

Mr. Edds informed council that the Hemple Road Project is close to being completed. The aprons should be completed this week, lay asphalt next and dirt work to complete job. The Center Street house received a new meter. Mr. Edds informed council that there was a problem at one of the wells which may be costly. Because of the cost to fix the well he has decided to not pursue the Hydro Truck from the City of Germantown. Mr. Lamb informed council that Superintendent Richardson would be at the November 25th meeting. The JEDD was briefly discussed. Mr. Dowden felt that it was in the best interest of all to go ahead and forum the JEDD and have the framework in place. Germantown will be paying for the lawyer fees.

NEW BUSINESS:

There was discussion regarding possibly rescheduling Trick or Treat because of the expected rainy, cold weather: the consensus of the group was to leave it on October 31st.


ADJOURN:
