VILLAGE OF FARMERSVILLE Minutes of Village Council Meeting August 22, 2011

The Farmersville Village Council met in regular session on August 22, 2011 in the Village of Farmersville Council Chambers at 117 E. Walnut St. Mayor Jeffery Morneault called the meeting to order at 7:00 pm; Ms. Walton led the group in prayer; the Pledge of Allegiance was recited and followed by a roll call.

COUNCIL MEMBERS PRESENT: Ms. Walton, Mr. Cottman, Ms. Morgan, Ms. Gisewite, Mr. Scarberry, Mr. Weller.

EMPLOYEES: Tom Sears, Administrator; Amy Schenck, Fiscal Officer.

Others in attendance: Law Director, Ryan Brunk; Joe Kelly, DP &L; Resident, Jeff Pope.

Mr. Cottman moved, Ms. Gisewite moved to approve the minutes of July 25, 2011 and August 8th as presented; there was some discussion questioning if both sets of minutes could be approved if the Council members that were absent on August 8th abstained; Mr. Brunk advised the Council to approve the minutes separately. Ms. Morgan confirmed that she was in attendance at both of these meetings.

Mr. Cottman moved, Ms. Gisewite moved to approve the minutes of July 25, 2011 as presented; Ms. Morgan confirmed that she was in attendance at this meeting. Roll Call: Mr. Cottman: yes, Ms. Morgan: yes, Ms. Gisewite: yes, Mr. Scarberry: yes, Mr. Weller: yes, Ms. Walton: yes. MOTION PASSED.

Ms. Gisewite moved, Mr. Cottman moved to approve the minutes of August 8, 2011 as presented. Roll Call: Mr. Weller: abstain, Ms. Walton: abstain, Mr. Cottman: yes, Ms. Morgan: yes, Ms. Gisewite: yes, Mr. Scarberry: abstain. MOTION PASSED.

Mr. Scarberry moved, Ms. Walton seconded to approve the bills for this period for a total of \$26,951.68 warrant number 29643-29690. Roll Call: Ms. Walton: yes, Mr. Cottman: yes, Ms. Morgan: yes, Ms. Gisewite: yes, Mr. Scarberry: yes, Mr. Weller: yes.

VISITOR COMMENTS:

Joe Kelly, DP&L presented an overview of the investment in reliability Dayton and Power & Light has made in the past year; including: line clearance (every 5 years), distribution line inspection and deficiencies addressed (every five years); pole inspection (every 10 years); distribution underground devices including inspecting the condition and security of transformers, pedestals, risers, and switchgears (every 5 years); and monthly substation inspections with emphasis on security. He provided additional information about the capital investments DP&L has invested in new technology and additional substations. The Mayor thanked Mr. Kelly for the presentation.

Jeff Pope, 75 N. Elm Street, addressed Council about the sewer backup damage he suffered to his basement during heavy rains in April. He explained that Roto Rooter is refusing to pay for the damage because they claim that he had changed the plumbing since they had been there last. Mr. Pope stated that he hoped to avoid a lawsuit and that he would like for the Village to pay to repair the damage to his home as they had paid the Clean & Dry Service bill. Mr. Brunk responded that Mr. Pope would have to sue Roto Rooter to recover his losses and that he expected that the Village would be involved in the suit as well to recover the payment to Clean and Dry Services.

LAW DIRECTOR COMMENTS:

Ryan Brunk reported that the acquisition of the Depot property was moving along. He discussed the 38 N. Main Street property and asked Council to approve Mr. Higlefort giving the property to the Village through a quit

claim deed. Mr. Brunk provided a detailed overview of the foreclosure process and explained that the 38 N. Main Street property had been foreclosed on but was never sold at Sheriff's auction, so essentially Mr. Higlefort remains the owner; through this action the Village will acquire the property and utilize grant funds to demolish the home to abate the nuisance. He asked Council to approve this gift tonight under new business. Mr. Brunk also reminded Council that the Montgomery County Fair would begin Wednesday August 31st and encouraged everyone to come out and visit the fair.

COMMITTEE COMMENTS:

Finance

Ms. Schenck reported that the Finance Committee met this evening and reviewed and discussed the end of the month reports including the municipal income tax collection report for July and had signed the bank reconciliation for July 31, 2011. Ms. Schenck reported that the committee had reviewed the bills on the agenda for Council's approval tonight and had recommended their approval.

MAYOR'S COMMENTS: None.

ADMINISTRATOR'S REPORT:

Mr. Sears provided the following report:

- Northeast Waterline Project would begin mid- September, after Maple, Vine, California.
- Maple, Vine and California Street Project work would begin immediately, two crews would work on project to minimize the impact on the school.
- OPWC Round 26 Applications- Street projects update at meeting
- Business First update- At meeting (Business Walk) (Think Twice Buy Local). Business Walk set for Sept 15th Think Twice Buy Local set for month of Oct- TV advertisements.
- Senior Housing- Setting up meeting August 29th w/Montgomery County Representatives, Ken Crews and Mayor, hoping to move forward with project, apply for grant funding.

Mr. Sears reported that they had located and repaired a water leak on Hemple near Elm. He reported that the Medical Center intended to buy the old Ford garage and expand the Medical Center, looking into grants to facilitate necessary upgrades. Mr. Sears is also working on negotiating a new street light contract. He reported that the new owner of the Village Inn had completely gutted the first floor, cleaned out the basement, stabilized the building and is working on the upstairs apartments, and was working toward abating code violations.

FISCAL OFFICER REPORT:

Ms. Schenck reported that the recent BWC audit has resulted in "No Findings" which is the best possible outcome.
