VILLAGE OF FARMERSVILLE Minutes of Village Council Meeting January 9, 2012

The Farmersville Village Council met in regular session on January 9, 2012 in the Village of Farmersville Council Chambers at 117 E. Walnut St. Mayor Jeffery Morneault called the meeting to order at 7:00 pm; Ms. Walton led the group in prayer; the Pledge of Allegiance was recited and followed by a roll call.

There was additional discussion about the vacation of the alley behind Mr. Johnson's house, including a variance being necessary, and Mr. Johnson's future plans for the property; Mr. Sears will follow up.
