**September 8, 2014**

The Farmersville Village Council met in regular session on Monday, September 8, 2014 in the Village of Farmersville Council Chambers at 117 E. Walnut Street. Mayor Morneault called the meeting to order at 7:00 pm and Mr. Weller led the group in prayer; the Pledge of Allegiance was recited and was followed by a roll call.

Mr. Brunk reported that he was working with Mr. Sears on certain property maintenance issues in the Village.

**PLANNING/ SERVICE COMMITTEES REPORT**

The committees reported that Center Street was badly deteriorated and would need to be replaced; they discussed the scope of work that was necessary and the costs of the project. Mr. Sears discussed upgrading the street lighting in the Village and the potential long term cost savings due to more efficient lighting options. There was additional discussion about possibly applying for a NatureWorks grant for a pedestrian walkway on Elm Street.

**VILLAGE ADMINISTRATOR REPORT:**

Mr. Sears reported that the Village office would be open for flu shots for the community on September 23 from 10 a.m. -12 p.m.; cost will be \$29.95 and they will invoice the insurance company. Mr. Sears reported that he has sent out several exterior maintenance violation letters, trying to get residents to clean up their property. He provided an update on the new weir plate for the Wastewater Treatment Plant and discussed the road salt supply and price increase, and the feral cat issue. He discussed the poor condition of the property at 320 Dean Drive and suggested that the Village clean it up and assess the property taxes.
