- # 3. To be completed only if you are required to complete Page 2 from the top of this sheet.
- # 7. A & B to be completed by Tax Office only, when tax has not been paid on time.
- # 8. Unless the space is checked as indicating a refund, your overpayment will be applied to your next year's estimate.
- # 9. Insert the amount of income you expect to make this year.
- # 10. Line (A) should reflect the amount of tax withheld by your employer for this Village.
Line (B) should correspond to the figure shown on line 7 unless a refund has been requested.
Line (C) refers only to income taxes you expect to pay another Taxing Jurisdiction.
- # 12. You may pay the entire amount declared with the filing of this form.
- # 14. If your company changes from a sole proprietorship to any other status, (i.e., incorporates, etc.) then you must utilize a business form. This also applies to line 15 and 16. These forms are available at the Village Office.
- # 16. Retirement, interest and dividend income are not taxable.
- # 18. A — Credit will be allowed only when a W-2 is attached and all expenses must be substantiated by proper schedules.
B — Applicable for residents employed in another community and only a percentage of income is taxable to that community by reason of extensive travel. Or persons who during the current year have moved in or out of this community. Or any other income included in attached W-2 and not taxable to this community. Please state reason.

ALSO: We do not give credit for Valley View School Tax.

The Village has a mandatory filing per Ordinance 240 if you are age 18 or older.
