

VILLAGE OF FARMERSVILLE
Minutes of Village Council Meeting
September 12, 2016

The Farmersville Village Council met in regular session on Monday, September 12, 2016 in the Village of Farmersville Council Chambers at 117 E. Walnut Street. Mayor Weller called the meeting to order at 7:00 p.m. and led the group in prayer; the Pledge of Allegiance was recited and was followed by a roll call.

Chief Wallace thanked the Village for the proclamation and commented that it was a good day to celebrate the 100th anniversary of the fire department.

LAW DIRECTOR COMMENTS:

Mr. Brunk provided an update on Ohio's new medical marijuana law and on the Good Samaritan law that provides protection to those who report a drug overdose.

FISCAL OFFICER REPORT:

Mrs. Schenck reported that the 2014-2015 audit was going very well and explained that Ordinance No. O2016-02 was the required annual legislation to assess the cost of streetlights to the Village residents.

Mr. Dowden announced that he will not be at the September 26th meeting.




ADJOURN:
