

VILLAGE OF FARMERSVILLE
Minutes of Village Council Meeting
March 27, 2017

The Farmersville Village Council met in regular session on March 27, 2017 in the Village of Farmersville Council Chambers at 117 E. Walnut St. Mayor Weller called the meeting to order at 7:00 pm; Pastor Jon Kibler led the group in prayer; the Pledge of Allegiance was recited and followed by a roll call.

Mr. Roach moved, Ms. Neitman seconded to approve the minutes of March 13, 2017. Ms. Gisewite stated that the March 13, 2017 minutes needed to include that FABA's proceeds would also be going towards flowers for the village. MAYOR'S COMMENTS:

Mr. Weller stated that he had received a letter from David M. Griffin regarding MOTORCYCLE AWARENESS MONTH in Ohio. A signed Proclamation by the Mayor will be forwarded to Mr. Griffin. Mr. Weller received a letter from the Ohio Department of Taxation Ways and Means Committee regarding centralized collection. Mr. Weller will prepare a letter in response.

ADMINISTRATOR'S REPORT:

Mr. Sears reported that there will be an EPA inspection at the Waste Water Treatment Plant tomorrow. He reported that the water line mapping had cost the village approximately \$7,700. He reported that he received the CDBG Grant information and there is approximately \$750,000 available. He will be meeting with Service and Planning Committee to go over what we are eligible for. Mr. Sears stated that if the Township Trustees approve the new electric rate package for the park the rates will decrease. The Village received the Montgomery County Solid Waste Program Agreement forms. Mr. Sears will forward the Agreement to the attorney for his review and recommendation. The last time it was approved was in 1985.

Mr. Sears gave an update on the park. The Park Board will be adding about \$1,000 worth of fish to the pond. There are 8 select baseball teams with home games on 4 diamonds. Twin Creek Mud Cats ages 7 – 14. Games will start April 10 and go through June. There will also be a tournament in June. Some new chairs were purchased for the Community Center. Dave Brill will be getting the pool de-winterized and Jeff Tully will be in charge of filling the pool and adding the necessary chemicals, etc. There has not been any hiring of a manager or asst. manager at this time. They are looking into hiring a part-time manager with 2 part-time assistant managers. They will be changing locks on the ball diamonds as they have on the Community Center.

Ms. Dill informed the council that a community newsletter would be coming out in May and asked if anyone had anything they wanted to include. ANNOUNCEMENTS:


Mr. Dowden will not be here for the meeting on April 10, 2017.


ADJOURN:
