- Problems at WTP due to line voltage from DP&L. Line voltage was corrected, but the transfer from generator power caused the SCADA breaker to trip. In return, that caused well pumps to not come on and the filter beds ran dry. Filters had to be backwashed multiple times to clear up water.
- Voltage was adjusted to fix low volt issue on generator. Found bad breaker to SCADA and a new breaker was
  ordered.
- Extra mulch for hydro-seeder was returned.
- Clean flag room and gather all old unserviceable flags to be brought to flag retirement ceremony at the American Legion in New Lebanon.
- Order Cl2 and So2 for water and waste water plants.
- Repair flags on poles.
- Put together trough and weir plate at WWTP to prep for install.
- Trim tree on W Center St.
- Dirt work on south side of Hemple Rd
