VISITOR COMMENTS:

Resident Anissa Evans complained that California Street has major potholes. She pays taxes and her street has never been paved. It's not right that her vehicles have to be subjected to bumps and loose gravel. Several people explained that grants were not available for roads that are not coming into or out of the Village and that the utility lines and infrastructure would have to be replaced before the paving work could be done.

Park Board Member Ryan Hodson stated that the Jackson Township Trustees and the Park Board Members are concerned about the costs to repair the pool. It needs a new liner and the deep end has a leak. The diving board will have to be removed. He discussed enlarging the pool by a few feet to allow for swim meets to be held there. He stated that they are trying to get water back to the restrooms. The Park Board is trying to maintain and improve the current park facilities. The area around the concession stand needs to be paved to allow wheelchair and stroller access and emergency services access. The Park Board meets the first Monday of the month. He suggested setting up a work session with the Jackson Township Trustees, the Village Council and the Park Board on Monday, August 24 at 7:30 p.m. at the park shelter.
