VILLAGE OF FARMERSVILLE Minutes of Village Council Meeting December 14, 2020

The Farmersville Village Council met via Zoom in response to the COVID-19 pandemic and the recommendation of the Montgomery County Health Department on December 14, 2020. Mayor Nick Lamb called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited and followed by a roll call.

COUNCIL MEMBERS PRESENT: Mr. Cunningham, Ms. Hadley, Mr. Roach, Mr. Craig, Mr. Holderman and Mr. Depew.

EMPLOYEES: Amy Schenck.

OTHER IN ATTENDANCE: Kirsten Knight, Chief Schade, Jackson Township Trustees Moyer, Hodson and DeVilbiss.

The Farmersville Village Council had a work session with the Jackson Township Trustees to discuss the bids that came in for pool repairs at the park. There were fourteen requests for specifications for the project and one bid received from Shamrock Enterprises. Mayor Lamb stated that the pool is the main attraction at the community park and it needs to be repaired but he didn't think any new features needed to be added. There was discussion about asking Shamrock for an estimate on the repair of the baby pool too. The group discussed the need for a 5 year plan and possibly hiring a park manager. The park manager would champion everything at the park, the short term projects and stay steady with the established 5 year plan. Having a park manager would provide continuity with local volunteers serving on the Park Board. The group discussed \$269,000 in the pool fund with the estimated year-end carryover and the levy proceeds. Trustee Moyer expressed his concern that \$1M has been spent on the pool over the last 12 years. The group discussed the Covid pandemic and whether or not the community pool would open in 2021. If the pool cannot open in 2021, what will need to be done to protect the investment and what are the costs? The group discussed the need to set up additional work sessions to discuss the bylaws, establishing a park manager position and the five year plan. After some discussion about whether or not to rebid the big pool and the baby pool as one big project, it was decided that Trustee Hodson will contact Shamrock and ask them to give an estimate on fixing the baby pool. The group was in favor of moving forward with that repair if it was less than \$50,000. The group discussed the need to repair the parking lot and the cost estimate to perform that work. There was discussion about the difficulty in recruiting new Park Board members. The group agreed that the Village and the Township needed quality minutes, bill reports and the budget. They agreed that \$35,000 was a good number for the park manager position. Trustee Moyer will send the ballot language for the pool levy out to the group so that it is clear what the levy money can be spent on.

Mr. Holderman moved, Mr. Depew seconded to approve the minutes of November 23, 2020. Roll Call: Mr. Roach: yes; Mr. Craig: yes; Mr. Holderman: yes; Mr. Depew: yes; Mr. Cunningham: yes; Ms. Hadley: yes. MOTION PASSED.

He reported that Jeff Morneault is no longer able to serve on the Personnel Committee and that Brenda Gisewite has been appointed to serve. He announced that Steve Morgan has decided not to take the Village Administrator position. The Council expressed their appreciation to him for taking on the role temporarily.

VILLAGE ADMINISTRATOR REPORT:

Mr. Morgan reported that the leaf pickup for 2020 has been completed. The service department has been busy hauling sludge and the paperwork for the Hemple Road project has been submitted.

Mrs. Schenck reported that she is continuing to work on the 2021 budget.
