

VILLAGE OF FARMERSVILLE
Minutes of Village Council Meeting

May 9th, 2022

On Monday May 9th, 2022, The Farmersville Village Council met in regular session, Mayor Nick Lamb called the meeting to order at 7:00pm. The Pledge of Allegiance was recited and followed by roll call.

COUNCIL MEMBERS PRESENT: Mr. Cunningham, Mr. Holderman, Ms. Hadley, Mr. Depew, Mr. Lewis.

Mr. Holderman moved, Mr. Cunningham seconded to approve the meeting minutes of April 25th, 2022. Roll Call: Mr. Lewis; yes, Mr. Cunningham; yes, Mr. Holderman; yes, Mr. Depew; yes, Ms. Hadley; yes. MOTION PASSED.

Mr. Cunningham moved, Mr. Holderman seconded to approve the bills for this period 73-82-2022 and warrant no. 36201-36211 totaling \$12,962.00. Roll Call: Mr. Lewis; yes, Ms. Hadley; yes, Mr. Cunningham; yes, Mr. Holderman; yes, Mr. Depew; yes. MOTION PASSED.

VISITOR COMMENTS: Mr. Smith inquired about a walkway being placed on Elm St. between the fire station and Walnut St. Mr. Shell reports Tom Sears has previously looked into this and will ask Mr. Sears why a walkway was not placed in this location before. Mayor Lamb agrees this would be a great addition to the Village. It would allow residents north of the fire station to access businesses in town more easily. Mayor Lamb reports Officer Moore has requested additional speed limit signs to be placed in the Village. Jackson Township has received a grant for additional safety signs and the additional signs in the Village will qualify under the grant. Mr. Moyer stated the Jackson Township Trustees have appointed their resident representative for the Park Committee. They appointed Josh Kohlreiser. Jackson Township Trustees have not appointed the trustee representative yet. They may hold a special meeting to appoint their rep. Mr. Moyer states the pool may only open limited hours or may not open at all, due to lack of lifeguards. Mr. Wallace reports there will be a dedication ceremony for the hometown hero

banners at Depot Pointe Park on Saturday, May 28th at 1:00pm. He asked Mayor Lamb to make a proclamation. Pastor Jon and Pastor Susan will speak at the ceremony. So far there will be 67 banners, there will be a reading of the names at the ceremony. Mr. Wallace reports FABA will pick-up the flowers for the Village pots from Stockslagers. FABA will pay for the flowers this year.

POLICE DEPARTMENT COMMENTS: Chief Schade reports he has noticed residents blowing grass clippings in the streets and roads. This is illegal. He would like the Village to post a notice on social media.

FIRE ASSOCIATION COMMENTS: Chief Erisman reports the Easter egg hunt went well. The Fire Association is taking donations for the community garage sale. Donations can be dropped off at the fire station. The Village will share this on the Village facebook page. Chief Erisman reports he has spoken with a rep from Kettering Medical Center about the now vacant office in the Village.

LAW DIRECTOR COMMENTS: none

MAYOR COMMENTS: Mayor Lamb reports there will be a groundbreaking ceremony for the new Valley View School building on June 2nd from 12:30- 2:00. Mayor Lamb asked Mr. Shell about the process of condemning the property at 18 W. Center St. Mr. Shell states he will start on it this week.

VILLAGE ADMINISTRATOR REPORT: Mr. Shell reports CG Construction will install the ADA ramps on California St. Kincaid will be completing asphalt on California St. Mr. Shell reports the filter media replacement has started. Mr. Shell reports he has ordered plants and trees from Vogel's and Stockslager's with the grant money awarded for the community garden. Mr. Shell reports he has met with Mote engineers on the sewer plant upgrade.

OLD BUSINESS: Mr. Holderman moved, Mr. Cunningham seconded to approve the rental agreement for 44 Maple St. Roll Call: Mr. Cunningham; yes, Mr. Holderman; yes, Mr. Depew; yes, Ms. Hadley; yes, Mr. Lewis; yes. MOTION PASSED.

NEW BUSINESS: none


ANNOUNCEMENTS: none


ADJOURN: Mr. Holderman moved, Mr. Cunningham seconded to adjourn the meeting at
