MAYOR COMMENTS: Mayor Lamb reached out to a developer in the Pittsburg, PA area that recently converted an old school building into luxury apartments.

VILLAGE ADMINISTRATOR REPORT: Mr. Shell reports that local funds could decrease for the Elm St. sidewalk project because of some grant opportunities. His team removed trees in the tree lawns on Center Street and Farmersville Pike; stumps will be removed soon. National Water agreed to purchase the new laterals and will move forward with the installation on filter bed 1 when they arrive. Derek is interested in running for a spot on the Ohio Rural Water board. The new electric meter for 44 Maple is \$1700, performed by Cunningham Electric. Derek suggested donating our enclosed trailer to the local Scout troop following the theft of theirs. Council agreed. 2 zoning violation letters sent. More will be delivered in the Spring for the purpose of cleaning up several properties in the Village. Remodel work at 53 California following the fire to begin in the Spring.

LEGISLATION: Mayor Lamb read Ordinance No. 2023-01, an ordinance submitting the question of renewing an existing 1.5 mill levy, in excess of the 10 mill limitation, for street fund construction, reconstruction, resurfacing, and repair of streets and roads in the village.
