**POLICE DEPARTMENT COMMENTS:** Chief Bruner reports there have been a few complaints on juveniles in the Village. The canine owner has put a fence up and the dogs are well contained.

**MAYOR COMMENTS:** Mayor Lamb reports USbank has announced the Farmersville branch will be closing on July 9<sup>th</sup>, 2024.Mayor Lamb would like to discuss how this will impact The Farmersville community and a vision for the empty building.

VILLAGE ADMINISTRATOR REPORT: Mr. Shell announced there are a couple of businesses interested in Sear's Hardware buildings. The property the buildings are on are two parcels. There is a sewer business and a gunsmith business interested. Mr. Shell reports he has been looking into finding a bank that would be interested in the USbank building once the bank closes. Mr. Cunningham mentioned USbank could have a clause not allowing another bank to move in until so many months have passed. Mr. Shell reports Choice One has completed the survey for the Elm St pedestrian path. A

pre-construction meeting will be set up soon. Mr. Shell announced he is a board alternate for OPWC and The Montgomery County Opioid committee. Mr. Shell reports the second clarifier was put into service, but the flow was not enough for 2 clarifiers, so just one clarifier is in service at the WTP. Mr. Shell reports Mike's Sanitation will only pump 2 loads of sludge a month moving forward. Mr. Shell reports there is a service break on N. Broadway and the resident has been notified. Mr. Shell would like to revisit the bulk water rates. The finance committee will discuss the bulk water rate at their next meeting.

**FISCAL OFFICERS REPORT:** Ms. Marascio stated she was concerned about USbank closing and how that would affect village business. She states she uses the bank every day. Ms. Marascio states if she needs to start using the Miamisburg branch, then she may limit her bank visits to 1-2 visits per week.
